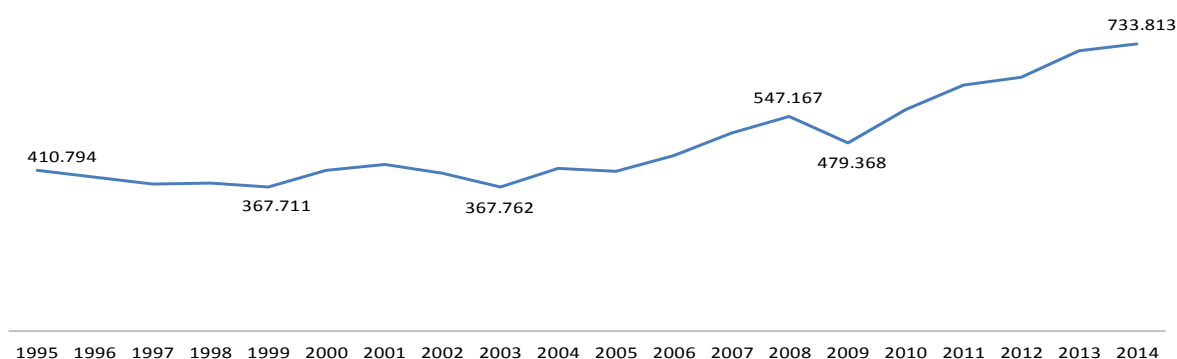

Introduction

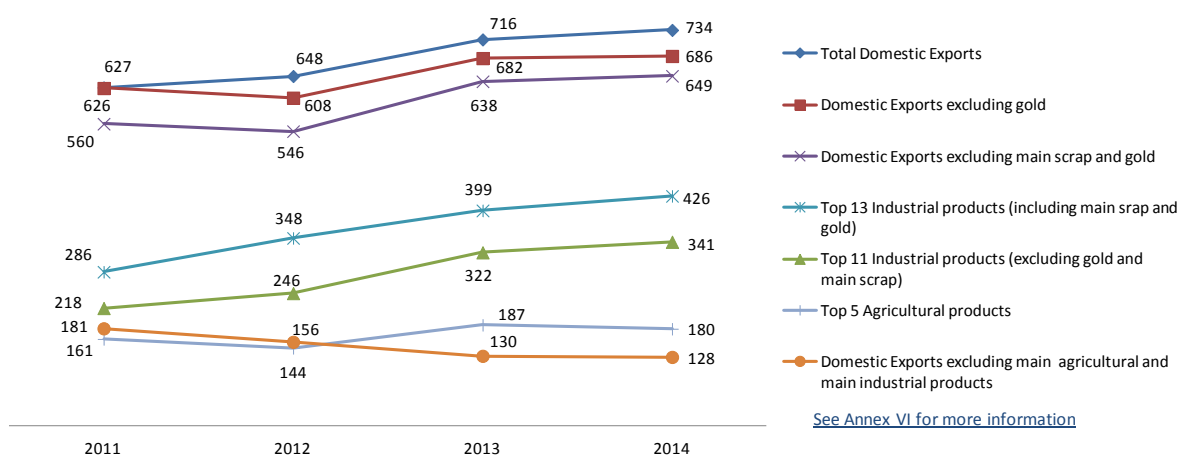
In the last twenty years domestic exports have almost doubled in value reaching €0,7 billion in 2014.

Domestic Exports 1995 - 2014 (in €millions)



Total domestic exports have been growing in the last 4 years. At the same time, as depicted in the figure below, we can see that exports of gold and scrap have contributed positively to this trend. Domestic exports of the main 13 industrial products (including gold and main scrap) have exhibited a positive increase each year in contrast with the top 5 agricultural products that exhibited positive and negative trends in the same period. Domestic exports excluding the top agricultural and industrial products have shown a negative trend which underlines the continuing and growing dependence of Cyprus on a small number of products.

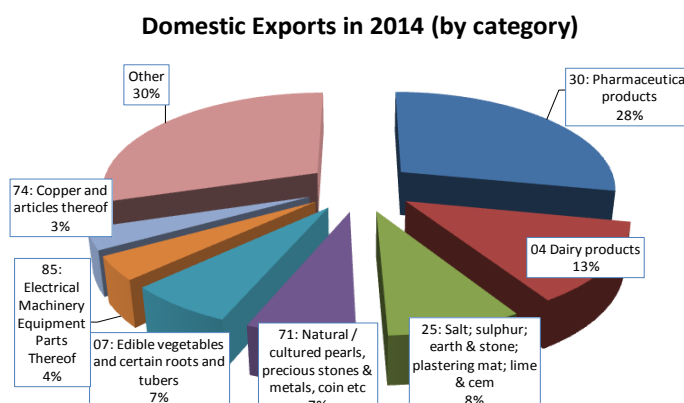
Domestic Exports trend in major products (in €millions)



In 2014 the EU was Cyprus' main export destination with a 47% share in total domestic exports. The top five export destinations were the UK, Israel, Greece, China, and Italy.

Domestic Exports (by category)

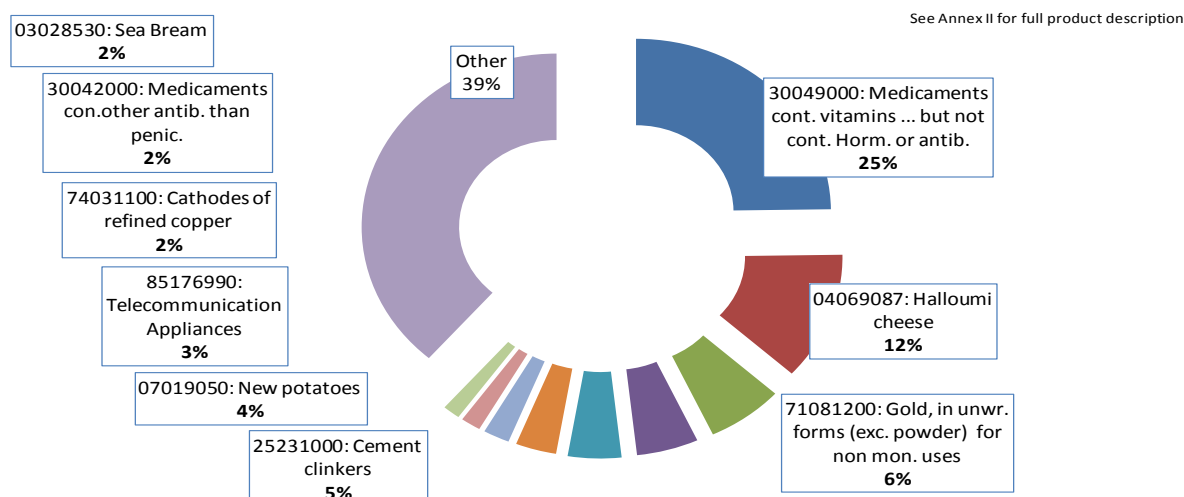
Pharmaceuticals has been the leading export category in the last years with a share of 28% (+2%) in total domestic exports in 2014, followed by dairy products (13%, +19%), salt, sulphur, earth and stone plastering mat etc (8%, +13,1%), natural cultured pearls (7%, +36%), vegetables (7%, -19%), electrical machinery equipment (4%, +45%) and copper and articles thereof (3%, -18,3%). Domestic Exports (by product)

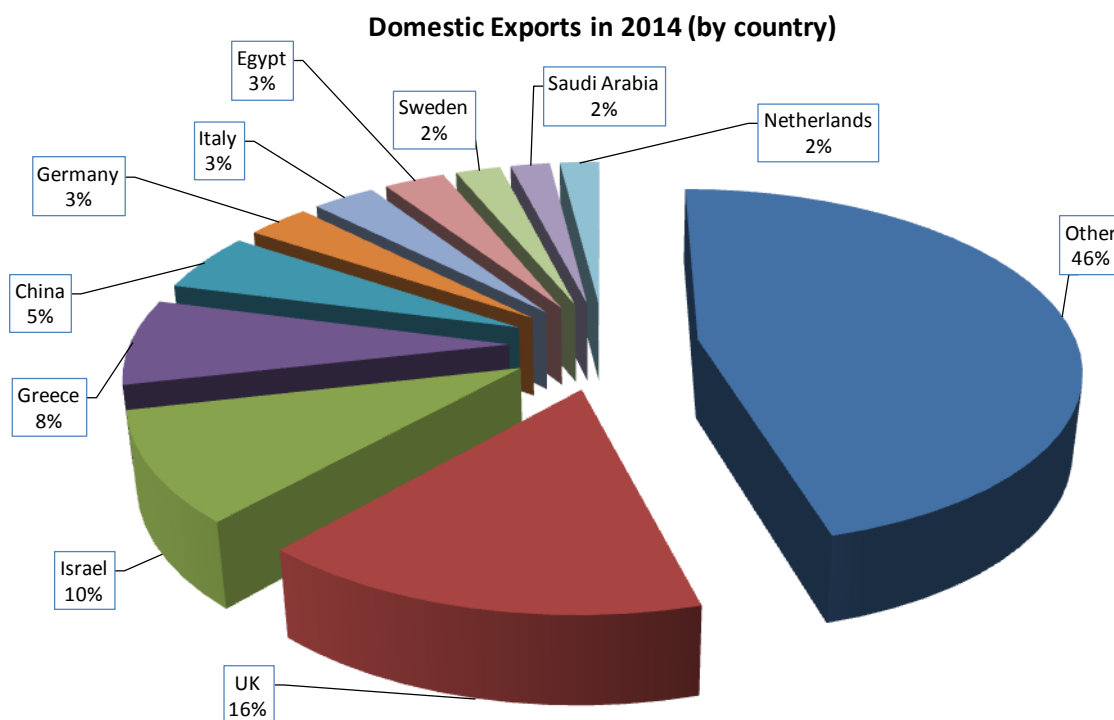
In the graph below we can see in more detail the main products exported from Cyprus in 2014. Halloumi cheese (customs code: 0406 90 87) exports which make up 12% of the overall domestic exports were up 20%. Exports of gold went up by 64%, cement clinkers by 43% and telecommunication appliances by 50%. Domestic exports of new potatoes, cathodes of copper and sea bream decreased by 23%, 23% and 25% respectively.

Domestic Exports (by country)

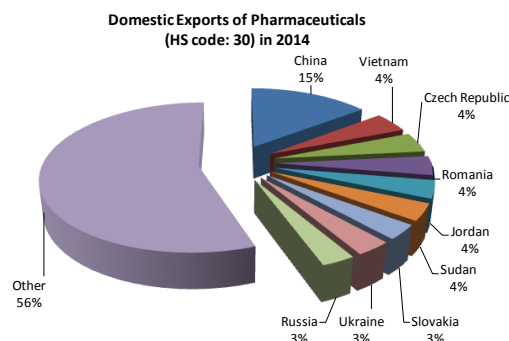
In 2014 the EU was Cyprus' main export destination with a 47% share in total domestic exports from 48% in 2013. Cyprus' top 8 export destinations accounted for 50% of total domestic exports which signifies the dependence of Cyprus on a small number of countries. Significant increases in domestic exports to main destinations of Cypriot products were noted in the case of Saudi Arabia (+78%), Israel (+53%), China (+26%) and the UK (+19%). Significant decreases were noted in the case of Greece (-18%) and Italy (-11%).



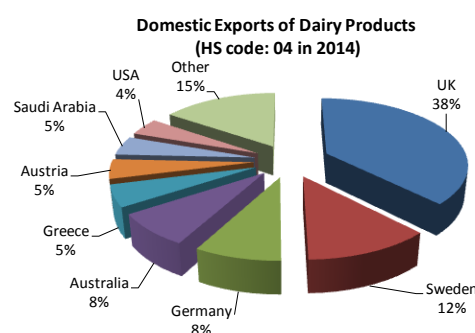
As regards the rest of the world it is worth underlying significant increases in domestic exports to Vietnam (+41%) and Australia (+24%) as well as substantial decreases to countries such as Russia (-40%), Libya (-40%), Ukraine (-34%), Egypt (-28%), Czech Republic (-21%) and Belgium (-13%). Domestic Exports (by category and by country)

In 2014 China was the leading export destination of pharmaceuticals from Cyprus with a share of 15%, followed by Vietnam (4%), the Czech Republic (4%), Romania (4%), Jordan (4%), Sudan (4%), Slovakia (3%), Ukraine (3%) and Russia (3%). Pharmaceuticals from Cyprus were exported to 128 countries in 2014.

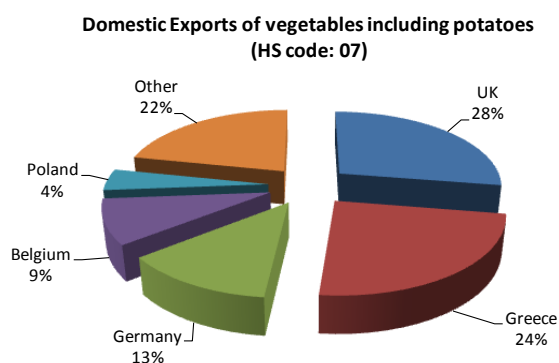


The UK, Sweden and Germany together accounted for almost 50% of total domestic exports of Dairy products (HS code: 04) followed by, Australia (8%), Greece (5%), Austria (5%), Saudi Arabia (5%) and USA (4%). Dairy products from Cyprus were exported to 45 countries around the world.



Salt, sulphur, earth & stone, plastering mat, lime & cem including cement (HS code: 25) was mainly exported to Israel (59%) and Egypt (20%). Natural cultured pearls including gold (HS code: 71) were exported mainly to the UK (94%).

UK and Greece together absorbed more than 50% of vegetables from Cyprus, followed by Germany (13%), Belgium (9%) and Poland (4%). The remaining 22% were exported to 25 countries mainly in Europe. See Annex IV and V for more information.
